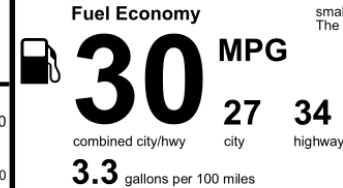

Gasoline Vehicle



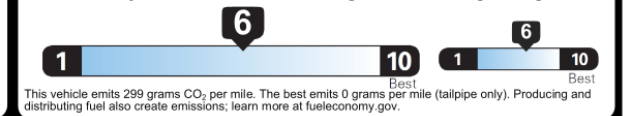

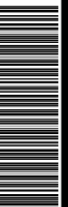
